- sexual innuendos
- unwanted touching of a woman or a girl

### **Crisis support**

We offer consultations to women and girls from the age of 14 who have experienced or averted sexual violence.

### **Psycho-social counselling**

Together with you, we will find ways to cope with this difficult situation.

### **Advice for associated persons**

We provide advice to relatives, companions, teachers, social workers and others.

### **Consultation on filing a complaint**

We offer consultations, if you want to file a complaint for sexual violence or have questions about court proceedings. Attending our consultation doesn't mean you have to file a complaint!

### **Court assistance according to Federal Ministry of Justice regulations**


We advise you on filing a complaint and on legal proceedings. We accompany you to the police and to court. Our advisors and our lawyers are present at trial.

**We are ...**

- **a team of women** who are experts on the subject of sexual violence.
- **Everything you tell us will remain confidential.**  
Nobody will find out your name if this is important to you. Nobody will find out that you came to see us.
- Our Counselling Centre exists since 1982. We are a private association and supported with public funds.\*
- **Our consultation and support are free.**  
The court assistance offered by our lawyers is also free of charge.
- In individual consultations, **together we will find ways to help you cope with the difficulties caused by your experience.**  
We will support you to regain control over your own life.
